#### Report of the 2016 Centenary Committee Meeting 5 August 2015

Councillor Leon Thorpe enquired why the embroidered shirts had been replaced with a vinyl logo. Mrs Donaldson advised that the embroidered logo would be difficult to replicate, vinyl being the easier material to work with, providing better clarity of images. Councillor Christine Stead advised the logo could be made larger with vinyl print.
