## Nominate now for the 2024 Australia Day Awards

Griffith City Council is now accepting nominations for this year's Australia Day Awards, which celebrate the remarkable contributions of local residents, community groups, and events. This is an opportunity to honour those who make a difference in our community. Submissions are open until Friday, 15 November 2024, with the awards to be presented at the Australia Day ceremony in January 2025.

Council's Community Development Coordinator, Melissa Canzian, said now is the time to acknowledge those who go above and beyond.

"Their selfless service deserves to be celebrated, ensuring their efforts don't go unnoticed," she said.

"I urge members of our community groups, sporting clubs, and service organisations to consider nominating someone for an Australia Day Award. Whether through leadership or action, these individuals play a vital role in enhancing the

city we live in, and they deserve recognition,"

## Early voting opens ahead of Local Government Elections

Griffith residents are reminded that the Local Government Election will be held this Saturday 14 September 2024, with voting compulsory for all eligible residents within the Local Government Area. Polling places will be open from 8am to 6pm on Election Day at the following locations:

For those unable to attend on Election Day, early voting is available from Saturday 7 to Friday 13 September 2024 (excluding Sunday 8 September) at the Griffith Regional Sports Centre, 15 Merrowie Street, Griffith.

Early voting is also available on Wednesday 11 to Friday 13 September at the Griffith Aboriginal Community Centre, 5 Wiradjuri Place, Griffith. Please check the

NSW Electoral Commission website for opening times of early voting centres and accessibility for all voting locations.

The Electoral Commission provides support for people living with disability to ensure a smooth voting process. If you need assistance at a polling venue, you can ask someone for help.

Venue staff are trained to assist, or you may nominate a friend, relative, or another person (other than a candidate) to help you. If you do not nominate anyone, a venue official may provide assistance. Additionally, if you are unable to leave your vehicle, ballot papers can be brought to you. For voters who are blind or have low vision, telephone-assisted voting will be available in the lead-up to Election Day.

Residents are reminded that postal votes must be received by the Electoral Commission no later than Friday 27 September 2024 to be counted.

## Dump for Free Month is back this October



With Spring well and truly in the air, Griffith City Council is pleased to announce the return of Dump for Free Month this October.

Residents can dispose of general domestic waste, including garden debris and mixed recyclables, free of charge from Tuesday 1 October to Thursday 31 October 2024.

Throughout October, each household is entitled to dispose of up to two standard loads, with a maximum of four car tyres per load. It is important to note that commercial or agricultural tyres will not be accepted.

A standard load is defined as equivalent to a car and trailer combination or a single car or ute load. It is crucial to adhere to these guidelines for a smooth and efficient disposal process.

Residents are reminded that hazardous materials such as asbestos will not be accepted during the Dump for Free event. Council encourages responsible waste disposal and urges residents to utilise the free Community Recycling Centre (CRC) located at the Tharbogang Waste Management Facility. The CRC serves as a permanent drop-off location for common household problem wastes that cannot be collected through Council kerbside waste and recycling collection services. The Tharbogang Waste Management Centre will be open from 8am to 5pm, seven days a week. Additionally, the Yenda Centre will be open from 1pm to 5pm on Sundays only.
